



A look into Musical.ly

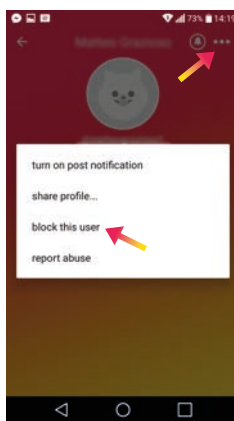
- 60 million users are using this application (app) on a daily basis.
- By downloading and using this app, you are automatically confirming that you are either aged 18 years+, or that you are 13 years old or over and have parental consent to use it.
- Users can also connect with friends/followers through a live stream.
- Users are encouraged to share videos across other social media platforms in order to gain fans.
- It is a social media music app where users can watch and create lip-syncing and /or dance videos.

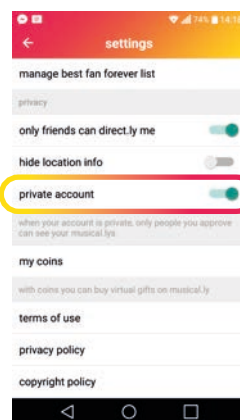
USEFUL TIPS:

- If you come across videos that make you and/or your friends feel uncomfortable – report them! You can report them directly to musical.ly or by calling 179.
- You may block users so that they cannot see your content. You can also delete a fan by swiping left.
- Keep comments positive – use them to show support and encourage privacy.
- It feels good to have many followers however be careful when trying to boost your followers. Apps that claim to help boost followers often cost money and are not the safest option.
- Remember: users may not be who they say they are, may have bad intentions and may hide behind a fake identity. Only accept people you know. **#safetyoverpopularity**.



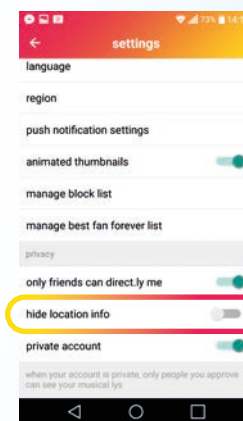
Privacy settings:

- 60 miljun utent juża din l-applikazzjoni (app) regolarment.
- Meta tuża din l-app inti awtomatikament tikkonferma li ghandek 18-il sena jew aktar, jew li ghandek 'il fuq minn 13-il sena u qed tuża din l-applikazzjoni bil-kunsens tal-ġenituri tiegħek.
- L-individwi li ghandhom *account* huma mhegġa biex itellghu vidjows fuq jattafformi oħra tal-midja soċjali sabieq jiksbu aktar *fans*.

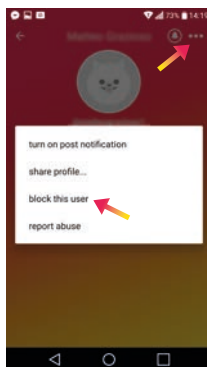
- Dawn l-individwi jistgħu wkoll jingħaqdu ma' shabhom/*followers* fuq din l-app, permezz ta' *live streaming*. Dan ifisser li l-individwu jista' jixgħel il-kamera u l-*followers* jistgħu jsegwu l-attività tiegħu/tagħha fil-hin attwali.

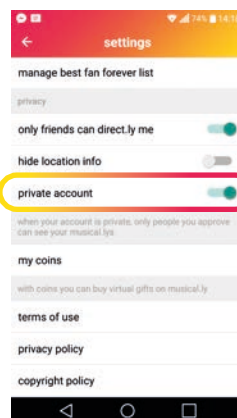
PARIRI SIEWJA:

- Jekk tiltaqa' ma' vidjows li jġiegħlu lilek jew lil shabek thossukom skomdi – irrappurtahom! Inti tista' tirraporta direttament fuq musical.ly jew billi ċċempel fuq il-helpline 179.
- Inti tista' timblokka individwi li ghandhom *account* biex ma jkunx jistgħu jaraw il-kontenut tiegħek. Tista' wkoll thassar *followers* billi tmexxi l-iskrin in-naħa tax-xellug.
- Żomm il-kummenti pożittivi – użahom biex turi appoġġ u tinkoraġġixxi l-privatezza.
- Thossok tajjeb meta jkollok hafna *followers*, iżda oqgħod attent meta tipprova tagħti spinta lill-ammont ta' *followers* tiegħek. Applikazzjonijiet li jgħidu li jzidulek il-*followers* tiegħek hafna drabi jiswew il-flus u jaf mhumiex l-aħjar mezz.
- Ftakar: individwi li ghandhom *account* jistgħu ma jkunux min qed jgħidu li huma u jistgħu jkunu qed jinħbew wara identità falza. Aċċetta biss nies li taf. **#safetyoverpopularity**.



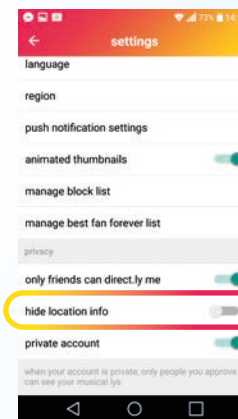
